CONTRACT AGREEMENT Contract No. 2024-08-0006

THIS AGREEMENT made the **9th** day of **August 2024** between **Department of** Education, Division of El Salvador City, located at Zone 3, Tuburan, Poblacion, El Salvador City of the Philippines, represented herein by its Schools Division Superintendent, RANDOLPH B. TORTOLA, (hereinafter called "the Entity") of the one part and THE LIFE-GIVING PRODUCTS AND SPECIALTY (MANHU - THE LIFE GIVING BREAD) CORP., represented herein by GILBERT A. GABUTAN, with office address at Indahag, Cagayan de Oro City (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, Delivery Supply and 2-**Procurement** of Lot particularly Fortified/Enriched Bread + Juice (Calamansi with Honey), for the Conduct of School-Based Feeding Program for SY 2024-2025 in the Division of El Salvador City (PN:2024-06-0018) and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of Three Hundred Fifty-Eight Thousand Nine Hundred Ninety-Two Pesos Only (Php 358, 992.00) (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of 1. Contract referred to.

Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- In consideration for the sum of Three Hundred Fifty-Eight 3. Thousand Nine Hundred Ninety-Two Pesos Only (Php 358, 992.00) or such other sums as may be ascertained, THE LIFE-AND SPECIALTY (MANHU-THE **PRODUCTS** LIFEGIVINGBREAD) CORP. agrees to supply and deliver for the Supply and Delivery of Lot 2-Procurement Fortified/Enriched Bread + Juice (Calamansi with Honey), for the Conduct of School-Based Feeding Program for SY 2024-2025 in the Division of El Salvador City (PN:2024-06-0018) in accordance with his Bid.
- 4. The Department of Education, Division of El Salvador City agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
