CONTRACT AGREEMENT
 Contract No. **2024-08-0007**

THIS AGREEMENT made the **9th** day of **August 2024** between **Department of Education, Division of El Salvador City**, located at Zone 3, Tuburan, Poblacion, El Salvador City of the Philippines, represented herein by its Schools Division Superintendent, **RANDOLPH B. TORTOLA**, (hereinafter called “the Entity”) of the one part and **ASAHI RESOURCES CORPORATION**, represented herein by **ALEJANDRO B. CUYOS**, with office address at No. 8, St. Dominic St., ITC Compound, Bagbaguin, Valenzuela City, Metro Manila (hereinafter called “the Supplier”) of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **Procurement of Lot 3- Supply and Delivery of NUTRI-PACK: Nutri-oats 35 grams +1 pc nutri-biscuit/nutri-graham 30 grams pack and NUTRI-PACK: Ready to Cook, Fortified Rice Porridge (Champorado) with PN: 2024-06-0019 for the Conduct of School-Based Feeding Program for SY 2024-2025 in the Division of El Salvador City** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Six Hundred Four Thousand Nine Hundred Sixty Eight Pesos Only (Php 604,968.00)** (hereinafter called “the Contract Price”).

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, *viz.*:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder’s bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder’s bidding envelopes, as annexes, and all other documents submitted (*e.g.*, Bidder’s response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity’s bid evaluation;

- iii. Performance Security;

Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**
3. In consideration for the sum of **Six Hundred Four Thousand Nine Hundred Sixty Eight Pesos Only (Php 604,968.00)** or such other sums as may be ascertained, **ASAHI RESOURCES CORPORATION** agrees to supply and deliver for the **Procurement of Lot 3- Supply and Delivery of NUTRI-PACK: Nutri-oats 35 grams +1 pc nutri-biscuit/nutri-graham 30 grams pack and NUTRI-PACK: Ready to Cook, Fortified Rice Porridge (Champorado) with PN: 2024-06-0019 for the Conduct of School-Based Feeding Program for SY 2024-2025 in the Division of El Salvador City** in accordance with his Bid.
4. The **Department of Education, Division of El Salvador City** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
5. The works referred to this Contract shall be executed within the contract duration of _____ days, which shall commence on _____ (date) and not earlier than the date of _____



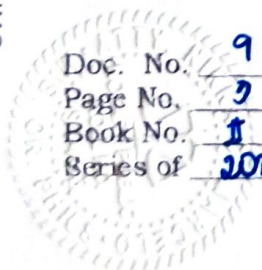
