CONTRACT AGREEMENT
 Contract No. 2024-08-0008

THIS AGREEMENT made the 9th day of August 2024 between **Department of Education, Division of El Salvador City**, located at Zone 3, Tuburan, Poblacion, El Salvador City of the Philippines, represented herein by its Schools Division Superintendent, **RANDOLPH B. TORTOLA**, (hereinafter called "the Entity") of the one part and **AICEE CATERING FOOD SERVICES**, represented herein by **REMEDIOS V. BASCO**, with office address at Lot 6-A B5 Corvette St. Thunderbird Subd Cimarín, Caloocan City, Metro Manila (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **Procurement of Lot 4- Supply and Delivery High Protein Biscuit with Sesame Seeds with PN: 2024-06-0020 for the Conduct of School-Based Feeding Program for SY 2024-2025 in the Division of El Salvador City** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **One Hundred Sixty-Four Thousand Three Hundred Eighty-Eight Pesos and Forty-Two Centavos Only (Php 164, 388.42)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

 - iii. Performance Security;
 - iv. Notice of Award of Contract; and the Bidder's conforme thereto;




