CONTRACT AGREEMENT Contract No. <u>2024-08-0011</u>

THIS AGREEMENT made the **9th** day of **August 2024** between **Department of** Education, Division of El Salvador City, located at Zone 3, Tuburan, Poblacion, El Salvador City of the Philippines, represented herein by its Schools Division Superintendent, RANDOLPH B. TORTOLA, (hereinafter called "the Entity") of the one part and THE LIFE-GIVING PRODUCTS AND SPECIALTY (MANHU - THE LIFE GIVING BREAD) CORP., represented herein by GILBERT A. GABUTAN, with office address at Indahag, Cagayan de Oro City (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly Procurement of Lot 7- Supply and Delivery of Nutricracker/Nutri-cookies + Juice (Kamotee Flavor) (PN: 2024-06-0023) for the Conduct of School-Based Feeding Program for SY 2024-2025 in the Division of El Salvador City and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of Three Hundred Ninety-Eight Thousand Eight Hundred Eighty Pesos Only (Php 398, 880.00) (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

In consideration for the sum of Three Hundred Ninety-Eight Thousand Eight Hundred Eighty Pesos Only (Php 398, 880.00) or such other sums as may be ascertained, THE LIFE-GIVING PRODUCTS AND SPECIALTY (MANHU-THE LIFEGIVINGBREAD) CORP. agrees to supply and deliver for the Procurement of Lot 7- Supply and Delivery of Nutricracker/Nutri-cookies + Juice (Kamotee Flavor) (PN: 2024-06-0023) for the Conduct of School-Based Feeding Program for SY 2024-2025 in the Division of El Salvador City in accordance with his Bid.


