CONTRACT AGREEMENT Contract No. 2024-08-0012

THIS AGREEMENT made the <u>9th</u> day of <u>August 2024</u> between **Department of Education**, **Division of El Salvador City**, located at Zone 3, Tuburan, Poblacion, El Salvador City of the Philippines, represented herein by its Schools Division Superintendent, **RANDOLPH B. TORTOLA**, (hereinafter called "the Entity") of the one part and **THE LIFE-GIVING PRODUCTS AND SPECIALTY (MANHU - THE LIFE GIVING BREAD) CORP.**, represented herein by <u>GILBERT A. GABUTAN</u>, with office address at Indahag, Cagayan de Oro City (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **Procurement of Lot 8- Supply and Delivery of Nutri-cracker with PN: 2024-06-0024 for the Conduct of School-Based Feeding Program for SY 2024-2025 in the Division of El Salvador City and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of One Hundred Fifty-Five Thousand Five Hundred Sixty-Three Pesos and Twenty Centavos Only (Php 155, 563.20) (hereinafter called "the Contract Price").**

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
- 2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, *viz.*:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;

 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto;

In consideration for the sum of One Hundred Fifty-Five Thousand Five Hundred Sixty-Three Pesos and Twenty Centavos Only (Php 155, 563.20) or such other sums as may be ascertained, THE LIFE-GIVING **PRODUCTS** AND SPECIALTY (MANHU-THE LIFEGIVINGBREAD) CORP. agrees to supply and deliver for the Procurement of Lot 8- Supply and Delivery of Nutri-cracker with PN: 2024-06-0024 for the Conduct of School-Based Feeding Program for SY 2024-2025 in the Division of El Salvador City in accordance with his Bid.
