

INVENTORY AND ASSESSMENT OF ELECTRICAL DISTRIBUTION LINES

- This Division is aware that one of the urgent concerns with regard to school
 facilities is the copper wire theft on our school electrical distribution lines.
 This leads to a potential failure of electrical supply throughout the school,
 which hinders school operations and activities and could result in high voltage
 discharge, which can be harmful to schoolchildren, school computers, and
 school equipment.
- 2. In order to address this, the school physical facilities coordinators and property custodian are directed to conduct an inventory and assessment of existing electrical distribution wires and electrical poles on the school grounds. Enclosed is a copy of the assessment form for your guidance.
- 3. The assessment form shall be thoroughly completed and is subject to the validation and evaluation of the division engineer for appropriate action.
