CONTRACT AGREEMENT Contract No. 2024-08-0010

THIS AGREEMENT made the 16th day of August 2024 between Department of Education, Division of El Salvador City, located at Zone 3, Tuburan, Poblacion, El Salvador City of the Philippines, represented herein by its Schools Division Superintendent, RANDOLPH B. TORTOLA, (hereinafter called "the Entity") of the one part and THE LIFE-GIVING PRODUCTS AND SPECIALTY (MANHU - THE LIFE GIVING BREAD) CORP., represented herein by NATHALIE D. GABUTAN, with office address at Indahag, Cagayan de Oro City (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly Procurement of Lot 1-Supply and Delivery of Enhanced Nutribun for the Conduct of School-Based Feeding Program for SY 2024-2025 in the Division of El Salvador City with PN: 2024-07-0025 (RE-BID) and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of Five Hundred Forty-Nine Thousand Five Hundred Forty Pesos and Thirty Centavos Only (Php 549, 540.30) (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
