REITERATION OF THE INITIATIVES UNDER GOOD EDUCATION IN BEAUTIFUL "SAVIOR SCHOOLS (GEBSS) AND GOOD EDUCATION IN BEAUTIFUL "SAVIOR CLASSROOM" (GEBSC)

- 1. The Office reiterates the provisions outlined in the Good Education in Beautiful "Savior Schools" (GEBSS) and Good Education in Beautiful "Savior Classroom" (GEBSC) initiatives to maintain a clean and healthy learning environment. To ensure that educational spaces meet these standards, all personnel are reminded to review and implement the physical specifications and requirements underscored in Division Memorandum 366, s.2023.
- 2. Further, well-designed and highly visible signage should be installed at all school entrances. These signs should prominently display the school's name and logo and be large enough to be read easily from a distance. To enhance visibility, they should be placed in well-lit areas, ensuring clear recognition of the premises both day and night. This approach will promote safety, minimize confusion, and create a welcoming environment for visitors, students, and staff.
- 3. Relative to this implementation, a monitoring and technical assistance provision shall be conducted in the entire month of September by the Office through the Schools Governance and Operations Division (SGOD). Thus, this Memorandum also serves as the Official Authority to travel of the identified monitoring team.
