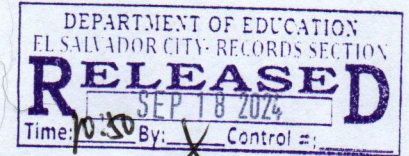

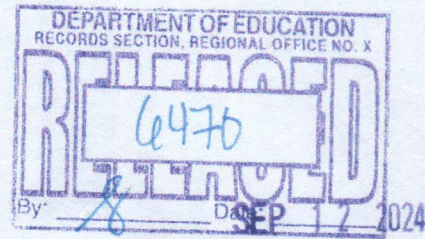


REGIONAL COORDINATION MEETING OF DEPED AND DPWH
