To: Schools Division Superintendents

- 1. Regarding Regional Memorandum No. 0682, s. 2024 titled Regional Unified Quarterly Assessment (RUQA), the test developers are reminded of the following aimed at enhancing the RUQA's development:
 - a. Use the font style Bookman Old Style.
 - b. Use the following font sizes: K Stage 1 (16), K Stage 2 (14), K Stages 3-4 (12).
 - c. Use single spacing.
 - d. Use the following margin to maximize space: 1 cm for top, bottom, left, and right margins.
 - e. Use the lower case for the four-letter options (a, b, c, d).
 - f. Color/highlight the correct answer with RED (no need to prepare a separate answer key).
 - g. The number of Test Questions (TQs) to be prepared for the different grade levels for reliability/validity testing are as follows: K Stage 1 (45), K Stage 2 (60), K Stages 3-4 (75).
 - h. Submit/resubmit the corrected/updated Table of Specification (TOS), Budget of Work (BoW), and the Test Questions (TQs in WORD file) for Quarters 2, 3, and 4 not later than September 23. Each of the regional education program supervisors for the different content areas will provide a specific Google link and email address to the divisional education program supervisors for the submission of the TOS, BoW, and the TQs.
 - i. DO NOT change or modify the assessment materials in any way.
 - j. Strengthen the dissemination of the Budget of Work (BoW) to all teachers.






