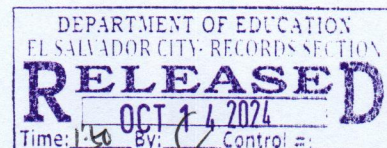


PARTICIPATION IN THE PROVINCIAL QUIZ BOWL



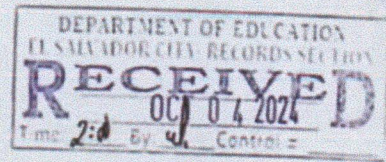
