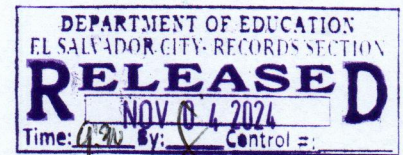

**KAMUSTAHAN SA PISA 2025 BATCH 2**

1. In preparation to the conduct of PISA 2025 and in pursuit to educational excellence, this Division shall conduct a Kamustahan PISA 2025 Batch 2 for ENSCIMA teachers to review performance in the implementation of PISA 2025 readiness and activities and do necessary adjustments to align tools and resources in the development of learner's competencies on November 4, 2024 at 10:00 a.m. to 4:30 p.m. at Cogon National High School, Cogon, El Salvador City.
2. The activity aims to:
  - a. increase the average scores of Filipino learners in reading, mathematics, and science in PISA 2025; and
  - b. increase in the percentage of Filipino learners performing at or above proficiency levels in PISA.
3. The participants of this activity are the secondary school heads, the education program supervisors of ENSCIMA, and all teachers handling English, Science and Mathematics from public secondary schools.
4. The participants are required to bring the following:
  - a. Weekly 2025 PISA Readiness Plan for PHASE 2: LEARNING SESSIONS IN THE DIGITAL WORLD
  - b. Weekly PISA Accomplishment Report
  - c. Harvested review materials for PISA
5. Moreover, participants are advised to bring their own provisions for the said activity.
6. This Office shall adhere to Equal Opportunity Principle (EOP) in receiving the General Plan of Activities and Attending to clarification/queries relative to the abovementioned activity. Hence, all decisions and actions shall be based on guidelines set forth, with no discrimination on the account of age, gender, identity, sexual orientation, civil status, disability, religion, ethnicity or political affiliation.


