

- 1. To ensure the success of the conduct of the El Salvador City Division Athletic Association (ESCDAA) Meet, this office through the Schools Governance and Operations Division, hereby informs the field of the Division Seminar-Workshop in Coaching, Officiating, and Sports Management at Taytay Elementary School on November 22-24, 2024.
- 2. This activity aims to:
 - a. train coaches and officiating officials in the different sports disciplines;
 - b. discuss and implement the updated rules and strategies in coaching and officiating; and
 - c. prepare coaches and officials for the conduct of the City Meet.
- 3. Participants in this training are coaches in Taekwondo, Table Tennis, Billiards, Sepak Takraw and Dance Sports. Furthermore, School Heads shall ensure to send at least 1 participant to every event as a representative.
- 4. The teacher-participants shall be entitled to service credits in accordance with DepEd Order No. 52, s. 2023 titled Updated Guidelines on the Grant of Vacation Service Credits for Teachers. However, non-teaching personnel shall be given Compensatory Time-Off (CTO) per Civil Service Commission (CSC) and Department of Budget and Management (DBM) Joint Circular No. 2, s. 2004 on Non-Monetary Remuneration for Overtime Service Rendered, specific attention on Section 5.
- 5. Further, this Memorandum serves as **Authority to Travel** of the Participants.
