**RESOLUTION TO AWARD**

**WHEREAS**, the Department of Education, Division of El Salvador City advertised the Invitation to Apply for Eligibility and to Bid for the **Procurement of Meals and Accommodation for the Regional Workshop on the Reconciliation of Accounts and Preparation of CY 2024 Year-End Financial Reports (January 12-18, 2025) of the Department of Education, Division of El Salvador City with PN No. 2024-10-147** and posted the same in the PhilGEPS;

**WHEREAS**, in response to the said advertisement/s, two (2) bidders submitted bids during the opening;

**WHEREAS**, during the opening of bids on *December 9, 2024*, one (1) bidder passed in the preliminary evaluation of bids with **HOTEL CONCHITA** as the lowest calculated bid as read below;

**WHEREAS**, after a detailed bid evaluation of **HOTEL CONCHITA** and **CHALI BEACH AND RESORT CORPORATION**, both passed for the Post Qualification Evaluation;

**WHEREAS**, during the post qualification of bids for **HOTEL CONCHITA** on *December 10, 2024*, the BAC declared it as *disqualified* due to the following reason:

1. The location lacks parking spaces as required in the end-user's Term of Reference. Such conditions results in congestion of vehicles for guests and participants leading to increase traffic around the area, longer wait times for parking, and reduced accessibility of the participants. Further, the declared parking space is actually part of the city road. It is not a private property of which the Hotel cannot exercise full control. Lastly, based from

the TOR of the end-user, it is required for the hotel to provide parking space for 20 vehicles which the Hotel cannot deliver;


**WHEREAS**, the BAC proceeded to conduct a post qualification evaluation of the next Lowest Calculated and Responsive Bid, **CHALI BEACH AND RESORT CORPORATION** on *December 19, 2024*, declared as *passed*, and therefore, considered for award of the contract;

**NOW, THEREFORE**, We, the members of the BAC, hereby RESOLVE as it is RESOLVED to recommend the award of contract to **CHALI BEACH AND RESORT CORPORATION** for the *Procurement of Meals and Accommodation for the Regional Workshop on the Reconciliation of Accounts and Preparation of CY 2024 Year-End Financial Reports (January 12-18, 2025) of the Department of Education, Division of El Salvador City with PN No. 2024-10-147* in the sum of **TWO MILLION ONE HUNDRED FIFTY-FOUR THOUSAND SIX HUNDRED PESOS ONLY (Php. 2,154,600.00)**.




